LIMITED LIFETIME WARRANTY

ToughGard™ and ToughGard™R
Fiber Glass Duct Liners

What and Who is Covered and for How Long

CertainTeed Corporation (CertainTeed), subject to the conditions and limitations listed herein, warrants to the original homeowner (purchaser) that its ToughGard™ and ToughGard™R Duct Liner products will be free from manufacturing defects, including defects related to the material or to the design of the duct liner, during the lifetime of the original purchaser so long as he/she retains ownership of the property in which the duct liner was installed. This warranty is intended to cover individual residences only. It is not applicable to duct liner installed in a building not used as an individual residence.

CertainTeed will correct the defect or supply replacement duct liner, at its election, free of charge, for any duct liner proven to be suffering from one of the foregoing defects during the above-stated warranty period following installation, up to a maximum liability which shall be equal to the cost of the duct liner required to replace the defective product. However, CertainTeed shall in no event be liable for any labor charges or other expenses whatsoever in connection with removal or installation of either the original or replacement duct liner except to the extent CertainTeed, at its election, corrects rather than replaces the duct liner determined to be defective.

In the event the original purchaser sells the residence in which the duct liner was installed, the coverage provided by this warranty will be transferred to the subsequent owner and will be limited in duration to 20 (twenty) years from the date of the installation of the duct liner.

How to Make a Claim

To obtain performance under this warranty, the original customer (or the subsequent property owner), installation contractor or duct liner supplier shall notify CertainTeed in writing of any defect promptly following its discovery and shall submit with such notice proof of date of purchase and installation in order to provide CertainTeed an opportunity to investigate the claim and examine the duct liner claimed to be defective. Notification shall be provided to CertainTeed Corporation, P.O. Box 860, Valley Forge, Pennsylvania 19482, Attention: IG Technical Services Department.

CertainTeed shall then promptly inspect the claimed defect and if such examination does disclose a defect covered by this warranty, shall, within a reasonable period of time after inspection, either correct or replace the defective duct liner subject to the terms set forth above.

Limitations

1. CertainTeed shall have no liability under this warranty for:
 - A. Defects or failure caused by improper storage or by installation of the duct liner not in strict adherence with the written instruction of CertainTeed.
 - B. Any damage to the duct liner caused by impact of foreign objects, by lightning, gale, hurricane, tornado, earthquake or other acts of God, by fire, explosion or other casualty.
 - C. Defects, failure or damage caused by materials adjacent to the duct liner.
 - D. Damage caused by alteration after completion of the installation of the duct liner, whether such alteration be by structural additions, changes, replacements, or by equipment installation, or as a result of post sale treatment with biocides, encapsulants, etc.
2. CertainTeed shall have no liability under this warranty for damage caused by or resulting from the cleaning of the lined duct system, unless the cleaning is performed in accordance with NAIMA A/H-122 (North American Insulation Manufacturers Association, Cleaning Fibrous Glass Insulated Air Duct Systems).
3. CertainTeed reserves the right to discontinue or modify any of its duct liner products without notice, and shall not be liable to the original customer (or the subsequent property owner), installation contractor or supplier as a result of such discontinuance or modification.
4. If CertainTeed replaces any duct liner under this warranty, it may substitute products designated by CertainTeed to be of comparable quality or price range in the event the product initially installed has been discontinued or modified.
5. THIS WARRANTY IS EXPRESSLY IN LIEU OF ALL OTHER ORAL OR WRITTEN WARRANTIES, LIABILITIES OR OBLIGATIONS OF CERTAINTEED. PERTINENT STATE LAW SHALL CONTROL FOR WHAT PERIOD OF TIME SUBSEQUENT TO SALE A CONSUMER/HOMEOWNER MAY SEEK A REMEDY PURSUANT TO THE IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT SHALL CERTAINTEED BE LIABLE FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES OF ANY KIND, INCLUDING ANY DAMAGE TO THE BUILDING, ITS CONTENTS OR ANY PERSON THEREIN. NO FIELD REPRESENTATIVE OR DISTRIBUTOR OR DEALER OF CERTAINTEED IS AUTHORIZED TO MAKE ANY CHANGE OR MODIFICATION TO THIS WARRANTY. SOME STATES MAY NOT ALLOW LIMITATIONS ON OR THE EXCLUSION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE EXCLUSIONS MAY NOT APPLY TO YOU.

This limited warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

This warranty is effective on ToughGard and ToughGard R Duct Liners installed subsequent to July 1, 2000.
