

CertainTeed 4's R Wild Sweepstakes

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR TO WIN.

NOT OPEN TO THE GENERAL PUBLIC.

VOID IN QUEBEC AND WHERE PROHIBITED BY LAW.

Eligibility: The CertainTeed 4's R Wild Sweepstakes ("Sweepstakes") is only open to permanent legal residents of the fifty (50) states of the U.S. (excluding Guam, Puerto Rico, and all other U.S. territories and possessions) and permanent legal residents of Canada (excluding the province of Quebec) who are currently physically located and residing therein, who are owners of a CertainTeed roofing and siding credentialed company (defined below), and who are eighteen (18) years of age or older as of date of entry. Entry into the Sweepstakes and receipt of a prize must not be against a participant's company policy. Participants must either have a valid social security number and/or a valid U.S. personal tax identification number or a social insurance number. Employees of CertainTeed Corporation ("Sponsor"), Sweepstakes administrator, advertising or promotion agencies, those involved in the production development, implementation, or handling, of the Sweepstakes, and any agents acting for the above entities, and their respective parent companies, officers, directors, subsidiaries, affiliates, service providers, prize suppliers, or any other person or entity associated with the Sweepstakes (collectively "Sweepstakes Entities") and members of their immediate families (spouses, domestic partners, children, siblings, parents) and/or persons living in the same household as such persons, whether related or not, are ineligible to enter Sweepstakes.

Description: The Sweepstakes begins at 6:00:00 a.m. Eastern Time ("ET") on May 1, 2020 and ends at 11:59:59 p.m. ET on August 31, 2020 ("Sweepstakes Period"). The Website's (defined below) computer is the official clock for all purposes of this Sweepstakes and all times refer to ET. The Sweepstakes will award one (1) grand prize and forty-four (44) prizes for a total of forty-five (45) prizes (see prizes below) to winners.

How To Enter: There are two (2) ways to enter the Sweepstakes: 1) by installing forty-four (44) roofs with SureStart PLUS™ 4-Star or 5-Star Coverage during the Sweepstakes Period and registering those same roofs for SureStart PLUS™ 4-Star or 5-Star Coverage warranties ("Warranty/ies") and 2) by mail without registering warranties. Only CertainTeed roofing credentialed company owners ("Owner(s)") can register a Warranty. There are two (2) ways to register a Warranty: (1) complete the Warranty via online registration at www.certainteed-myedge.com ("Website") or 2) mail a completed Warranty to: CertainTeed SureStart PLUS™, P.O. Box 20126, Lehigh Valley, PA 18002-0126. A total of forty-four (44) SureStart PLUS™ 4-Star or 5-Star Coverage Warranties must be registered by an Owner for said Owner to receive one (1) entry ("Warranty Entry") in the Sweepstakes. Warranties registered for apartment buildings, HOAs, condominiums, townhouses, churches, commercial properties, and all structures not used as a residence are excluded from being counted as an eligible Warranty in this Sweepstakes. SureStart PLUS™ 3-Star warranties are excluded from being counted as an eligible Warranty in this Sweepstakes. The Warranty provides extended coverage for a property owner's roof system products that are manufactured by the Sponsor. Owners register a Warranty on behalf of a property owner who elects to purchase the Warranty. Warranties can be completed and registered one at a time, in batches, or all at once. All information in the Warranty must be completed in full ("Warranty Information"). For purposes of this Sweepstakes, if an Owner registers more than forty-four (44) Warranties during the Sweepstakes Period, it will result in no additional compensation, entries, or eligibility for a prize. Warranty Entries must be received by 11:59:59 p.m. ET on September 20, 2020 for the Sweepstakes. Limit one (1) Warranty

Entry per Owner. Warranty Entries sent by mail must be postmarked by September 7, 2020 and received by September 20, 2020.

To enter without registering a Warranty(ies): Obtain a postcard (no larger than 5" x 7") enclosed in a business size (#10) envelope and legibly hand-print your first name, last name, complete home address (no P.O. Boxes), Province (if applicable), zip code or postal code (if applicable), telephone number (including area code), email address (optional), date of birth, company name, company mailing address (no P.O. Boxes) and provide a short answer to the question, "Why do you think SureStart PLUS™ 4-Star or 5-Star Coverage is valued by roofing contractors and property owners?" ("Entry Information"). Then mail with proper postage affixed to: CertainTeed 4's R Wild Sweepstakes, P.O. Box 20126, Lehigh Valley, PA 18002-0126 ("Mail Entry"). Mail Entries must be mailed separately, postmarked by September 7, 2020 and received by September 20, 2020. Limit one (1) Mail Entry per Owner.

No copies, facsimiles or reproductions of Warranty Entries or Mail Entries (collectively, "Entries") of any kind will be accepted. YOU CAN ONLY ENTER BY ONE METHOD OF ENTRY. YOU CANNOT USE BOTH METHODS OF ENTRY TO ENTER. ENTRANTS WHO ENTER BY BOTH METHODS OF ENTRY, AS WELL AS THOSE ENTRANTS WHO SUBMIT MULTIPLE ENTRIES OF ANY KIND IN EXCESS OF THE LIMITS STATED HEREIN, WILL BE DISQUALIFIED. All required Warranty Information and Entry Information must be completed in full. The Warranty Information/Entry Information must match the information of the entrant that completed the act of physically entering the Sweepstakes. Proof of submitting an Entry will not be deemed by Sponsor as proof of receipt or entry into the Sweepstakes. Any attempted form of Entry into this Sweepstakes other than as described herein is void. If an entrant is a resident of a jurisdiction that deems him/her to be a minor, he/she must obtain parental/legal guardian consent prior to entering or submitting any personally identifiable information. A minor is defined as a resident of Alabama or Nebraska in the U.S. or a resident of the province of Newfoundland and Labrador, New Brunswick, Northwest Territories, Nova Scotia, Nunavut or the Yukon in Canada who is under nineteen (19) years of age or a resident of Mississippi who is under twenty-one (21) years of age ("Minor"). If entrants use a mobile device to submit a Warranty(ies) and obtain a Warranty Entry, standard text messaging and data rates apply to them and all other mobile communications, including but not limited to additional Warranty submissions (if applicable), sent and received in connection with the Sweepstakes (contact applicable carrier for pricing plans and details). This charge will be billed on each entrant's wireless bill or deducted from each entrant's prepaid balance. Please use care and do not drive while entering the Sweepstakes. Final eligibility for the award of any prize is subject to eligibility verification and other conditions and requirements, as set forth below. The Website may not be accessible from all mobile service providers, mobile phones, handheld devices, and/or tablets. If an entrant experiences any issues entering, he/she should access the Website from a desktop or laptop computer.

Selection of Winners: Potential winners will be randomly selected from among all eligible Entries received in a drawing to be held on or about September 30, 2020 ("Drawing Date") by the Sponsor in Malvern, PA.

Notification of Winners: The Sponsor will notify each potential winner by telephone within approximately two (2) weeks of the Drawing Date. If a potential winner is a resident of a jurisdiction that deems him/her to be a Minor, his/her parent or legal guardian will be notified instead. If a Canadian resident is selected as a potential winner in a drawing, he/she must correctly answer a time-based mathematical skill testing question which will be administered over the telephone by the Sponsor. If a potential winner cannot be reached after three (3) phone call attempts within two (2) business days, or if a potential winner is found to be ineligible, or if he/she cannot or does not comply with these Official Rules, and/or if his/her prize or prize notification is returned as undeliverable, and/or if Canadian, he/she cannot correctly answer the time-based mathematical skill testing question, that potential winner will not be eligible for the prize and an alternate winner will be selected in Sponsor's sole discretion.

Affidavit/Release: Potential winners (or if a resident of a jurisdiction that deems him/her to be a Minor, his /her parent or legal guardian) must sign, execute, have notarized and return an Affidavit of Eligibility, a Liability Release (where legal), a Publicity Release (subject to applicable law), and any other documentation that Sponsor

requires (collectively “Affidavit/Release”), within five (5) days after receipt by potential winner or such potential winner may be disqualified and an alternate potential winner may be selected. If a winner is a resident of a jurisdiction that deems him/her to be a Minor, prize will be awarded in the name of his/her parent/legal guardian, who must sign the Affidavit/Release on his/her behalf. By returning the completed Affidavit/Release, each winner attests to the authenticity of his/her winning Entry. If a credentialed company has more than one (1) Owner, the Owners must come to an agreement about who the potential winner actually is and said agreed upon potential winner will be the individual to whom the Affidavit/Release is sent and to whom the prize is awarded. If the Owners cannot come to an agreement on whom the potential winner is within ten (10) business days after being notified, the potential prize will be forfeited and no additional compensation will be awarded to that Owner(s).

Prizes/Odds of Winning: One (1) prize will be awarded per potential winner, for a total of forty-five (45) prizes in this Sweepstakes. **Odds of winning a prize depends on the total number of eligible Entries received during the Sweepstakes Period. Total ARV of all Prizes: \$96,000.00 U.S.** Prize notifications will be mailed/shipped to street addresses in the U.S. (including D.C.) or Canada (excluding the province of Quebec) only. Any depiction of prize(s) in Sweepstakes materials or otherwise, are for illustrative purposes only. All federal, state, provincial, or other tax liabilities (including but not limited to income taxes) arising from participation in the Sweepstakes or award of any prize(s) will be the sole responsibility of each winner. If prize value is \$600 or more, U.S. winners will be issued an IRS Form 1099 from the Sponsor(s) or Sponsor’s designee for the total ARV of the prize won (as stated herein) in the calendar year won. Winners are solely responsible for any and all costs, incidentals, and any other expenses not specifically mentioned as being included, including but not limited to, Canadian import/export fees. No substitution or transfer for a prize except that Sponsor, at its sole discretion, may substitute a prize of equal value. Sweepstakes administrator is not the supplier or guarantor of any prize.

General Conditions: Sweepstakes is subject to these Official Rules and all federal, state, provincial and local laws and regulations (collectively “Rules and Laws”). By entering the Sweepstakes, entrants agree and acknowledge to be bound by these Rules and Laws, as well as the decisions of the Sweepstakes administrator which are final and binding in all respects; to waive any rights to claim ambiguity with these Rules and Laws and the Official Rules; to indemnify and hold harmless the Sweepstakes Entities from any and all liability resulting or arising from use of any submitted Entry; and to release all rights to bring any claim, action, or proceeding against the Sweepstakes Entities. Once submitted, Entries become the sole property of the Sponsor and will not be returned. Subject to the permissions granted in this paragraph, any personal information supplied by entrants to Sponsor or its affiliates will be subject to Sponsor’s privacy policy, located at <http://www.certainteed.com/legal-terms-of-use/privacy-policy>. Sponsor will not provide any personally identifying information of Minors, regardless of its source, to any third party without the express written consent of an entrant’s parent/legal guardian. Sponsor reserves the right, in its sole discretion, to disqualify any individual found to be tampering with the entry process or the operation of the Sweepstakes; to be acting in violation of the Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to annoy, abuse, threaten, or harass any other person. Any person attempting to defraud or tamper with Sweepstakes will be prosecuted and is not eligible for a prize. If, for any reason, the Sweepstakes is not capable of running as originally planned, Sponsor in its discretion, reserves the right to cancel, suspend, or modify the Sweepstakes or any portion(s) thereof and to conduct the drawing(s) and award the applicable prize(s) from all salvageable eligible Entries received prior to and/or after (as appropriate) the action taken by the Sponsor, or award the prize(s) in a manner that is fair and equitable.

Disclaimers: Sweepstakes Entities are not responsible or liable for Entries that are entered by other than human means (such as by an automated computer program or any non-human mechanism, entity, or device), in excess of the stated limit, or for Entries that are illegible, late, tampered with, forged, incomplete, misdirected, deleted, damaged, lost, misplaced, stolen, destroyed, dropped, postage due, mutilated, or otherwise not in compliance with these Official Rules and such Entries will be disqualified. The failure of Sponsor to comply with any provision of these Official Rules due to an act of God, hurricane, war, fire, riot, earthquake, terrorism, act of public enemies, actions of governmental authorities outside of the control of Sponsor (excepting compliance with applicable codes and regulations) or other *force majeure* event will not be considered a breach of these Official Rules.

GOVERNING LAW, JURISDICTION, ARBITRATION: Any controversy or claim arising out of or relating to (i) the Sweepstakes, (ii) the awarding or redemption of any prize and/or (iii) the determination of the scope or applicability of these Official Rules or their enforcement or interpretation shall be governed by and construed in accordance with the substantive laws of the state of Pennsylvania without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws. Any controversy or claim arising out of or relating to this agreement, its enforcement, arbitrability or interpretation shall be submitted to final and binding arbitration, to be held in Chester County, Pennsylvania before a single arbitrator. The arbitrator shall be selected by mutual agreement of Sponsor(s) and the entrant or entrants bringing forth the controversy or claim (collectively, the "Parties") or, if the Parties cannot agree, then by striking from a list of arbitrators supplied by the American Arbitration Association or JAMS/Endispute. The arbitration shall be a confidential proceeding, closed to the general public. The arbitrator shall issue a written opinion stating the essential findings and conclusions upon which the arbitrator's award is based. The Parties will share equally in payment of the arbitrator's fees and arbitration expenses and any other costs unique to the arbitration hearing (recognizing that each side bears its own deposition, witness, expert and attorneys' fees and other expenses to the same extent as if the matter were being heard in court). Entrant(s) agrees that his/her claim will be resolved individually, exclusively by arbitration, without resort to any form of class action. Each entrant(s) further agrees that any claim/judgment/award in such arbitration shall be limited to actual out-of-pocket costs incurred, including costs associated with participating in the Sweepstakes and in no event will entrant(s) be permitted to obtain attorneys' fees, other legal costs and/or be entitled to awards. Entrant(s) hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or increased. Should any term

of this section be deemed void, unenforceable or contrary to law, such term shall, but only to the extent necessary to bring this section within the requirements of law, be deemed to be severed from the other terms of these Official Rules, and the remainder of these Official Rules shall be given effect as if it had not included the severed term herein. THE PARTIES HEREBY WAIVE THEIR RIGHT TO JURY TRIAL WITH RESPECT TO ALL CLAIMS AND ISSUES ARISING OUT OF OR RELATING TO THIS AGREEMENT WHETHER SOUNDING IN CONTRACT OR TORT, AND INCLUDING ANY CLAIM FOR FRAUDULENT INDUCEMENT THEREOF.
